Marketplace Table Guidelines

On behalf of the Marketplace Committee for the NCC Silver Rush 2017—25th Anniversary Gathering, we would like to extend an invitation to you to participate as a Merchandise Vendor in our “Marketplace”. Our event will be held at the Tempe Mission Palms in Tempe, AZ on Friday, June 16, 2017 and Saturday, June 17, 2017.

The Marketplace will be open from 9:00 a.m. to 5:00 p.m. on Friday, June 16, and from 8:00 a.m. to 4:00 p.m. on Saturday, June 17.

THE FOLLOWING ARE THE MARKETPLACE GUIDELINES AND REQUIREMENTS:

1. The Marketplace is for the sale of retired Department 56 products and items related to enhancing village displays only. No current Department 56 lighted houses or related accessories shall be sold. Pieces must be of good quality. Items that are damaged or missing parts should be clearly marked on the sale tags. Bad pieces should not be brought to the Marketplace.
2. Setup time is on Thursday, June 15 after 3:00 p.m., and takedown is Saturday, June 17 after 4:00 p.m.
3. The cost will be \$75.00 per table for the weekend (one or two days). Tables are six (6) feet in length. Table assignments will be included in your information packet. NO MOVING of tables is permitted for any reason.
4. Exhibitors are responsible for collecting and reporting all sales tax. Exhibitors agree to abide by all city, county and State laws; fire safety codes; and to comply with regulations of the host hotel.
5. One free sign will be provided to each Exhibitor and all Exhibitors will be listed in the program booklet.
6. All sellers will be required to contribute a door prize with a minimum value of \$50.00. Items must be donated before 8:00 a.m. Friday, June 16.
7. Security will be provided for after hours. Each vendor is responsible for the security of his/her own products.
8. All transactions are between the buyer and the seller. The NCC Silver Rush 2017—25th Anniversary Gathering assumes no responsibility for the credit worthiness of any individual in attendance.

Activities planned for the three-day event will be included in future information packets.
